## **BREEDING CONTRACT**

This certifies	, hereafter referred to	as Mare

the above named stallion and will herei	n be referred to as Breeder.	-

- 1. A non-refundable Booking Fee of \$200.00 (USD) is payable with this contract and the balance of \$\_\_\_\_\_\_, plus all unpaid expenses, will be payable upon receipt of an invoice, when the mare leaves the farm, or prior to first shipment if shipped semen is needed, whichever is first. The Breeder requires 48 hours advance notice when Mare Owner wishes to remove his mare from the farm.
- 2. A copy of both sides of mare's registration papers, a veterinarian's health certificate (including uterine culture on open mares), worming, and immunization records must be presented upon mare's arrival at farm. If these items are not presented upon mare's arrival, the Breeder shall have a veterinarian of Breeder's choice make proper tests and evaluations at the Mare Owner's expense. Flu and rhinopneumonitis vaccines must be given before mare arrives.
- 3. A current Coggins test shall be furnished upon delivery of mare to the farm. NO MARES WILL BE ACCEPTED WITHOUT CURRENT COGGINS.
- 4. 18% interest will be charged on all accounts in excess of 30 days. All mares left more than 30 days after confirmation of pregnancy, without prior agreement, will be charged double boarding fees.
- 5. The Mare Owner shall agree that each mare offered for breeding shall be in sound breeding condition and free from infection and disease. Any mare certified by the attending veterinarian not to be, in his opinion, in sound breeding condition, shall not be bred. Mare Owner may substitute another mare within the same breeding season.
- 6. The Breeder agrees to diligently try and settle mare and shall have sole discretion of determining the best method of breeding such mare. If however, the mare does not settle, the Breeder shall held harmless. There will be no guarantee of a live foal for any mare leaving farm on or before being checked safe in foal by the attending veterinarian.
- 7. Live Colored Foal Guarantee. Live Colored Foal means the foal shall stand and nurse and have markings that will enable it to obtain registration papers from the Regular Registry of the American Paint Horse Association. It is understood that if the mare proves barren, aborts her foal, if the foal is stillborn, or if the foal is unable to obtain registration papers from the Regular Registry of the American Paint Horse Association, are turn breeding will be guaranteed for the following year only, providing proper notification of a non-live foal is given. Proper notification means: Written certification by a licensed veterinarian within seven days that the mare has aborted or produced a non-viable foal. Mare Owner certifies that such abortion or death did not result from any act or omission of the Mare Owner or his agent.
- 8. Waiver of Liability: It is understood that the farm, its owners, employees, veterinarians, and guests shall not be liable for any injury, escape, disability, or death or any horse on it premises. The Mare Owner will not be liable for any

damage, injury, or death to the breeding farm stallion, employees, veterinarians, equipment, or other animals on the farm.

- 9. The breeding season for this contract shall open February 15, 20\_\_\_\_ and close June 1, 20\_\_\_\_.
- 10. A breeder's certificate will be issued to the Mare Owner after all expenses have been paid in full, container is returned, and upon notification of birth of the foal.
- 11. When the Mare Owner signs and returns one copy of this contract to the Breeder, it will then be a binding contract.
- 12. Expenses will be charged as follows:
  - a. Stall Board with Turnout: \$15/day dry; \$20/wet
  - b. Collections: \$250/each
  - c. Shipping: actual cost
  - d. Counter to Counter: actual flight cost plus \$50
  - e. Farrier and Veterinarian expenses as necessary on mare
